The challenges of 2010 have been great, but our volunteers and supporters have helped ICS make many miracles happen - large

and small - for people in need. We hope you will enjoy this newsletter which is filled with news, acknowledgements of our volunteers and supporters, and events.

Here is an update on our two challenge gifts: The Wolslager Foundation challenge grant for the new ICS Food Bank building, and the Jenkins challenge for the ICS Endowment.

**Food Bank Building.** We are very close to reaching the \$200,000 needed for the \$150,000 challenge grant from The Wolslager Foundation. We expect to receive final cost estimates by April to give us time to raise additional funds as needed for the construction and furnishings. Projections

are to complete the building by the end of September 2011, just in time for the next holiday season. Remember, all gifts of \$500 or more will

be recognized in a display in the building. Thank you for your support.

**ICS Endowment.** Early in 2010, we announced the wonderful Jenkins gift and challenge for the ICS Endowment. This gift included an outright donation of \$250,000 with a dollar-for-dollar match of other endowment gifts up to \$750,000. Many individuals came forward to support the Endowment. We are close to fulfilling the Jenkins match - with \$50,000 to go. Planned gifts to the Endowment are also encouraged and will be matched as well. Our goal for 2011 is to complete this challenge. We would love to have you join us.

## ICS helps record number celebrate the holidays

With your help, ICS made the holidays brighter for more Pima County individuals and families in need than ever before.

In November and December, volunteers worked outside in the Ina Road office parking lot assembling Holiday Food Packages from donated food stored in six PODS.

ICS distributed **1,552 Holiday Food Packages** between November 22 and December 22, nearly 20% more than the 1,317 distributed last year.

*"I want to thank you all for giving me and my family...many extra things so we can enjoy our Christmas dinner together," one recipient said. "All of you have done so much good."*

The Food Bank also distributed **2,590 emergency food boxes** from November 1 to December 22, up from 1,974 in 2009 and averaging **more than 60 a day**.

### Gifts of Love

ICS's **Holiday "Gifts of Love"** program put gifts under the tree for **82 individuals and families** in need, up from 52 last year.

Many thanks to the **26 donor individuals and families; 10 businesses, schools and groups; and members of 11 faith communities** who "adopted" and provided gifts for the men, women and children whose holidays would otherwise have been less happy.

## Food Bank building coming soon!

Thanks to your overwhelming and generous response to our request for support, ICS will have a beautiful, new Food Bank building in about nine months!

We told you in early November that the Wolslager Foundation had committed \$150,000 to the building's estimated \$350,000 construction cost if ICS could raise the remaining \$200,000. With your help, we will reach that goal soon.

The new building will be 2,700 square feet, compared to the 400 square feet the Food Bank occupies in our main office plus

200 square feet in the outdoor storage shed.

We are planning for walk-in and smaller display refrigerators and freezers that will allow ICS to regularly provide fruits, vegetables and other

fresh nutritious food.

We need to obtain construction permits and seek bids on the project. We plan now to break ground in May and finish construction by the end of September.

There's still time to contribute. Remember, all gifts of \$500 or more will be recognized in a display in the building.

### Half-time Food Bank Coordinator opening

Frank Hayes, who has managed the ICS Food Bank as a volunteer since late 2004, is stepping down March 31.

**Edward Jones Bag-a-Thon:** Ken Blanchard of Edward Jones expanded his fourth annual "Bag-a-Thon" food drive for ICS beyond the 18 Edward Jones offices in Oro Valley, Tucson and Marana that participated last year and recruited the Town of Oro Valley, Ironwood Ridge and Canyon del Oro high schools, Copper Creek Elementary and Immaculate Heart schools, and Cub Scout Pack 209.

The result: **25,461 pounds of food!**  
 "For next year, we can absolutely do more, and we want to get more people involved," Ken was quoted as saying in the *Arizona Daily Star*. "Our goal will be 30,000 pounds of food. I'll stop doing this when there's no longer people facing a challenging time. Until then, we will continue."



**PODS:** Our friends at PODS provide the portable storage units in our Ina Road office parking lot that have become crucial to our ability to store food donations for our Food Bank and our Holiday Food Packages.

Their generosity has grown as the need for food in our community – and

ICS's ability to address that need – has grown. Back in 2004, **two PODS** helped us store the overflow of food from our outdoor shed and assemble the **290 Holiday Food Packages** we gave to people in need during the November and December holiday season.

By 2008, we needed **four PODS** and last year, for the first time, we needed **six PODS**. We gave out **1,552 Holiday Food Packages**.

ICS Food Bank Coordinator Frank Hayes estimates that renting the portable storage units since 2004 would have cost ICS about \$12,000. **That is a mighty generous gift!**

## Notes from the Planned Giving Advisory Council

### Estate Tax Update

Finally, Congress passed the "Tax Relief, Unemployment Insurance Reauthorization, and Job Creation Act of 2010" (Relief Act) on December 17, 2010. Here is a summary of some of the important estate and gift tax provisions of the recently enacted legislation.

The law in 2001 phased-out the estate and generation-skipping transfer taxes so that they were fully repealed in 2010, lowered the gift tax rate to 35% and increased the gift tax exemption to \$1 million for 2010. The 2010 Tax Relief Act reinstates the estate tax and sets the exemption at \$5 million per person and \$10 million per couple.

The tax rate is set at 35% for estate, gift and generation-skipping transfer taxes through 2012. The changes are effective January 1, 2010. However, a personal representative is allowed to make an election to choose no estate tax together with the modified carryover basis for estates of individuals who died on or after January 1, 2010, and before January 1, 2011. Each estate of an individual who died in 2010 must be evaluated to determine whether to allow the



estate tax to be imposed on amounts in excess of \$5 million or whether to elect out of the new law and be subject to no tax combined with a limited basis adjustment. Also, a \$5 million generation-skipping transfer tax exemption and zero percent rate will apply for the 2010 year. For gifts made after December 31, 2010, estate and gift taxes will be reunified.

Effective for estates of decedents dying after December 31, 2010, the 2010 Relief Act will allow the personal representative of a deceased spouse's estate to transfer any unused exemption to the surviving spouse. This is referred to as "portability."

The forms upon which to make the tax or no tax elections, basis adjustments, portability confirmation or the other required filings are not yet published. Much is yet to be interpreted and explained.

Please note that this legislation expires at the end of 2012, so there is certainty ONLY for 2010, 2011 and 2012. We must wait and see what, if any, action Congress takes to extend or to repeal the recently enacted legislation. If past performance is any indication, we may not know what taxes will apply in 2013 until well into that year.

Estate plans should be systematically reviewed to be certain the new legislation has not had an adverse impact.

## Faith and Health - Health Advocacy Outreach

Through our Health Advocacy Outreach program, ICS continues to work with congregations interested in developing or enhancing their own health ministries/programs. These services in a congregation could include such activities as prayer groups, nutrition classes, visiting the sick, or referrals to community resources. In this way, more people access needed health resources and do so in the context of their faith.

ICS and **Carondelet Health Network** are expanding our collaboration to reach even more congregations through

training geared to congregation health leaders who are not nurses. Trainings have already been held in October 2010 and January 2011. Additional sessions of *Basic Training for Congregation Health Leaders* will take place in April, July, and October 2011. Through these two-day trainings, we look forward to helping congregation health leaders gain tools and inspiration to foster whole-person health among their faith communities and neighborhoods.
